- The Van G. Miller Adult Learning Center is set to open January 2019 and will feature more than a dozen services doubling the capacity of students that can be served.
- EPI's Children and Family Services department started the Black Hawk Child Care Coalition bringing together other organizations, legislators, business owners, and funders. This sparked the idea for EPI and Hawkeye to develop this innovative partnership.
- The gap between available child care and children in need is growing in Black Hawk County while the number of child care programs continue to decline. According to lowaCCRR.org, the total number of child care providers has declined by 41% over the last 5 years.

## **EPI Partnering with Hawkeye Community College** to Open Child Care Center in Waterloo

As the need for reliable child care continues to grow, EPI and Hawkeye Community College are partnering to provide a solution to this critical problem.

The Van G. Miller Adult Learning Center being developed in downtown Waterloo by Hawkeye will house a child care center which will be run by EPI.

"Families in the Cedar Valley struggle to find child care. Our Child Care Resource & Referral office sees the struggle daily as we help families try to find child care," stated EPI's Children and Family Services Director, Mary Janssen.

With the child care shortage, businesses and organizations, such as EPI, struggle to find and keep employees.

"Safe, affordable, and enriching child care is such an incredible

need in our community and we see that with our employees," Chris Sparks, Executive Director at EPI said. "We as an organization have been wanting to offer this benefit to staff for a very long time."

Janssen went on to say, "Economic growth cannot happen in the Cedar Valley without access to Child Care for our families."

The child care center, located at the intersection of Jefferson Street and West Mullan Avenue in downtown Waterloo, will have 56 spots for children who are infant through preschool age.

EPI staff and Hawkeye Community College students, as well as staff, will have first choice for child care spots. Unfilled spots by either organization will then be open to the public.

#### A Message from Executive **Director Chris Sparks**

Cement, one of the most fundamental building blocks, is still ever-changing. Always looking for new ways to help it dry faster, hold stronger, and last longer. Like cement, service organizations, have to evolve and adapt to the constantly changing world around us. And just like the pioneers of EPI, we must create new paths and new opportunities for the people we serve and their families.

We must start here - with our Direct Support Professionals (DSPs) - where the service interaction takes place. DSPs help people acquire needed skills to live successfully. They are a key confidante and advocate for those with whom they work, developing trusting relationships along the way.

Yet, as rewarding as the DSP profession is, it's incredibly difficult to find and keep the kind of quality staff needed. We have spent years working to improve our DSP recruitment and retention. Still, vacancies and turnover remains an issue.

Making all our efforts more challenging is the fact that as a predominantly Medicaidfunded service we have limited access to rate increases by which we are able to pay our DSPs.

#### What do we do about all of this?

This is a complex problem and we must treat it as such. Our advocacy for adequate funding simply has to continue. It is critical we leverage all support offered by technology so people with disabilities can live with more privacy while still having access to help when needed, and allowing us to deploy staff only when absolutely necessary.

We have to use every creative idea we have and work together to prospect for solutions.




